Applicants submitting the form by post are required to send complete filled form, cash/DD Rs. 500 along with four passport size photographs with their name and discipline, in which they have applied for Ph.D. Programme, written on the back of the photographs, two sets of attested copies of testimonials (X, XII, U.G., P.G., Marks sheets, Caste Certificate for reservation category and Aadhar Card Copy)
- 2. Applicants need to carry any one of the following at the venue of entrance test as well as at the time of interaction with R.D.C. :
 - Driving License
 - Aadhar Card
 - PAN Card
 - Passport
- 3. Any person applying for Ph.D. admission should have a Master's degree or a professional degree declared equivalent to the Master's degree by the corresponding statutory regulatory body, with at least 55% (50% for SC, ST, OBC non-creamy layer, Differently abled and others as well as for those who had obtained their Master's degree prior to 19th September, 1991) marks in aggregate or its equivalent grade 'B' in the UGC –point scale (or an equivalent grade in a point scale wherever grading system is followed) or an equivalent degree from a foreign educational Institution accredited by an Assessment and Accreditation Agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country for the purpose of assessing, accrediting or assuring quality and standards of educational institutions.
- **4.** The eligibility marks of 55% (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the reservation categories mentioned above are permissible based only on the qualifying marks without including the grace mark procedures.
- 5. Candidates who have cleared the M.Phil. course work with at least 55% marks in aggregate or its equivalent grade 'B' in the UGC 7-point scale (or an equivalent grade in a point scale wherever grading system is followed) and successfully completing the M.Phil. Degree shall be eligible to proceed to do research work leading to the Ph. D. Degree in the same Institution in an integrated programme. A relaxation of 5% of marks, from 55% to 50%, or an equivalent relaxation of grade, may be allowed for those belonging to SC/ST/OBC (non-creamy layer)differently-abled and other categories of candidates as per the decision of the Commission from time to time.
- 6. Candidates possessing a Degree considered equivalent to M.Phil. Degree of an Indian Institution, from a Foreign Educational Institution accredited by an Assessment and Accreditation Agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country for the purpose of assessing, accrediting or assuring quality and standards of educational institutions, shall be eligible for admission to Ph.D. programme.
